FAQ's in Response to Hurricane Harvey

I'm a homeowner, can I bring in my drinking water for analysis?

We typically recommend that homeowners contact a certified consultant or inspector for water analysis. Consultants are able to give guidance on how to properly sample, which analytes are recommended to test for, how to interpret the results and what the next steps are if contamination is found. We do have a list of consultants for referrals, and would happy to provide you with their contact information. However, in light of the current circumstances, EMLab P&K is accepting drinking water for analysis from homeowners.

What do I collect the sample in?

It is recommended that the samples be collected in containers supplied by the lab, in order to prevent any outside factors to affect the accuracy of the results.

Where should I collect the sample from, well or faucet?

The Texas Commission on Environmental Quality's (TCEQ) website provides protocols and guidelines on sampling. After I collect the samples, are there any special instructions before they are delivered to the lab?

Upon collection of the samples, please fill out a Chain of Custody which provides sample identification, sample collection time, contact information and special instructions, amongst other information. Additionally, samples that are not chlorinated need to be delivered to the lab within 6 hours. If you are not certain if your water is chlorinated, please deliver to the lab within 6 hours to avoid inconsistencies.
